**RESOLUTION OF THE COMMISSIONERS OF  
FIRE DISTRICT NO. 2 IN THE TOWNSHIP OF  
BUENA VISTA, COUNTY OF ATLANTIC, A BODY CORPORATE  
ORGANIZED IN ACCORDANCE WITH N.J.S.A. 40A:14-70 APPOINTING  
ONE OF ITS OFFICERS AS CUSTODIAN OF RECORDS**

**WHEREAS**, the Commissioners of Buena Vista Fire District No. 2 in Atlantic County, New Jersey (hereinafter “Board of Fire Commissioners”), constitute a public agency, which is required to abide by the Open Public Records Act (OPRA), N.J.S.A. 47:1A-1 to 13; and,

**WHEREAS**, the purpose of OPRA is to maximize public knowledge about public affairs in order to ensure an informed citizenry and to minimize the evils inherent in a secluded process; and,

**WHEREAS**, OPRA requires every public agency, other than municipalities, to officially designate an officer, by formal action of the agency’s governing body, to serve as the custodian of government records of the agency; and,

**WHEREAS**, it is necessary for the Commissioners of Buena Vista Fire District No. 2 in Atlantic County, New Jersey to take formal action to designate one of its officers to serve as the custodian of records of the Fire Commissioners; and,

**WHEREAS**, it is appropriate and proper for the Commissioners of the Fire District to appoint its Secretary, Wayne Corsiglia, as Custodian of Records of, and for, the Commissioners of the Fire District.

**NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:**


That Wayne Corsiglia, Secretary, is hereby appointed, by way of formal action, memorialized by this Resolution, to serve as Government Custodian of Records of, and for, the Fire Commissioners of Buena Vista Fire District No. 2, in Atlantic County, New Jersey.
